This Water Right was filed in Meagher County by one Joseph Simms in or about 1893 - when we were later embraced within Yellowstone, Fergus and Musselshell Counties.

No transcript was made of this record so when Golden Valley County was created, there was no County record. An action was as instituted in about 1913 or 1914 in the District Court. It was appealed and then restored and it was held to be a valid ditch as to receive water when available.

Simms sold to the Enterprise Land Co. who in turn sold to Whurlook and Whurlook who sold this land, under this ditch, in parcels, and their conveyance allocated 1/1500 of the water right—to this land conveyed to each acre sold that was then irrigated or susceptible of irrigation,




