KNOW ALL MEN BY THESE PRESENTS: That the State Water Conservation Board of the State of Montana hereby declares its intention to store, control and/or divert unappropriated waters, to-wit:

All unappropriated waters of the Yellowstone River and Tributaries, together with the return flow of all waters furnished or supplied by seeping or overflowing from the previous place of use of the above appropriated waters.

Said waters will be appropriated by means of a diversion on the Yellowstone River, Sec. 1, T. 6 N., R. 37 E., Treasure County, Montana.

Said waters will be put to the following uses: Irrigation, flood prevention, drainage, fish and wildlife, recreation, development of power, watering of stock, supplying of water for public, domestic, industrial or other uses and for fire protection in the general area of the project.

This declaration is made and filed under the provisions of Section 89-121 of the Revised Codes of Montana, 1947, as amended.


