Dear Ms. Stromberg:

This is in reference to the enclosed GW-4 form, <u>Declaration of Vested Ground-water Rights</u>, that you filed on May 15, 1972, at 11:00 A.M. (Document number 36398) in the Powell County Courthouse at Deer Lodge, Montana.

The <u>Declaration of Vested Groundwater Rights</u> form was intended for appropriators to file on vested groundwater rights for a certain period of time only. That period was from January 1, 1962 to January 1, 1966. Therefore, after January 1, 1966, according to the Groundwater Code, the CW-4 form was invalid and could not legally be used as an appropriation form.

The proper form to use for wells filed on or after January 1, 1966, is the Notice of Completion of Groundwater Appropriation By Means of Well, referred to as the GW-2 form. Blank copies of the GW-2 form are enclosed for your use. Please complete all blanks as accurately as possible and attach any available proof that the date of first beneficial use did actually date back to 1942 as indicated on the enclosed GW-4 form that you filed on May 15, 1972. It is to your advantage to file and attach additional proof, if available, in case there is a dispute over groundwater in your area.

Also enclosed is a pamphlet, Appropriation and Regulation of Ground Water. The first three and one-half pages of the pamphlet should be of most interest to you. Note the red underlined areas which relate specifically to your particular case.

When you have completed the form, it should be recorded and filed with the Powell County Clerk & Recorder at Deer Lodge.

Note that the CW-2 form has five (5) pages to a set. You may discard or destroy the last page or green sheet, since it is usually kept by the licensed commercial well driller. Since this is a dug type well you would be considered the driller or person doing the well construction in this case. Take the remaining four pages with you to the courthouse for filing.

The first page (white) or original is kept in the courthouse for a permanent record; the second page (yellow) or duplicate is sent to this office by the Clerk & Recorder; the third page (blue) or triplicate is sent to the Montana Bureau of Mines and Geology in Butte by the Clerk & Recorder; and the fourth






